



Licensing

- Some permitting and licensing is the responsibility of the municipal officers or the Code Enforcement Officer, but a few licensing responsibilities are delegated in state law to the municipal clerk.
- The MMA Municipal Licensing Handbook is an invaluable resource which gives the statute reference, the licensing authority, the fees and how they are established, licensing and revocation procedures and the license expiration.





Licenses required through State Law



- Alcohol/Liquor (on-premise consumption) only in towns that have authorized this though a local option referendum (28-A Sec. 123)
- Beano/Bingo consent needed from municipal officers
- Bottle Clubs must receive permission from municipal officers
- Closing Out Sales issued by municipal officers, or their designee
- Innkeepers License municipal officers serve as the licensing board
- Junkyards municipal officers serve as licensing board
- Off-track betting- municipal officers must approve
- Special Amusement municipal officers must approve after public hearing



Licenses that may be adopted through Ordinance

- Bowling Alleys
- Pool Halls
- Clams/Shellfish
- Eating Establishments
- Mobile Food Vendor
- Explosives
- Itinerant Vendors
- Moorings
- Pawnbrokers
- Pinball machines
- Roller Skating Rinks
- Taxicabs





Other miscellaneous clerk "stuff"

- Auctioneer Licenses every auctioneer must show their license upon request of the municipal officers, municipal clerk or law enforcement in the town where the auction is taking place.
- Service of Process a civil action against a municipality starts with service of a summons and complaint by a sheriff or constable.
- Maine Tort Claims Act notice of claims of negligence by the municipality must be served to the clerk or municipal officers.





More "stuff"

- Business Filings \$10 filing fee
 - Sole Proprietor (D/B/A)
 - Mercantile/Partnership
 - Withdrawal
- Hospital Liens \$5 filing fee
- DD-214
 - Clerks file discharge or release papers of veterans for \$4 and retains forever
 - Confidential Record for 75 years
 - Copies only released to veteran, the spouse, power of attorney of veteran or the attorney of any of these, a member of the military department in their official capacity, or an administrator of the Maine Veterans' Home.
